## Part IV Declaration by Candidate

4. the applicant is under the age of 18;
5. the applicant has attained the age of 70 and she fails to produce a valid medical certificate certifying that she is physically fit to perform the functions of a manager;
6. the applicant is under the age of 70 and she fails to produce, upon request by the Permanent Secretary, a valid medical certificate certifying that he is physically fit to perform the functions of a manager;
7. in making or in connection with any application —
  - (i) for registration of a school;
  - (ii) for registration as a manager or a teacher; or
  - (iii) to employ (a person) as a permitted teacher in a school,  
the applicant has made any statement or furnished any information which is false in any material particular or by reason of the omission of any material particular;
8. the applicant is a bankrupt within the meaning of the Bankruptcy Ordinance (Cap. 6) or has entered into a voluntary arrangement under that Ordinance;
9. the applicant has previously been convicted in Hong Kong or elsewhere of a criminal offence punishable with imprisonment; or
10. the applicant has been registered as a manager of 5 or more schools.
